## **National Civics Bee Giveaway**

## Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY.

- 1) Contest Overview: Enter the National Civics Bee Giveaway for a chance to win a \$100 Amazon gift card.
- **2) Sponsor**: The National Civics Bee Giveaway ("**Giveaway**") is sponsored by Khan Academy, Inc. located at P.O. Box 1630, Mountain View, CA 94042 ("**Sponsor**").

By participating in this Giveaway, each entrant (and, if under 18, her/his parent or legal guardian) agrees to abide by these Official Rules and decisions of Khan Academy ("Sponsor"), which shall be final and binding in all respects relating to this Giveaway.

- 5) How to Enter: To participate in this Giveaway, parents (or legal guardians) and teachers will receive an email with instructions to submit a screenshot of the confirmation email showing that the student has registered for the National Civics Bee contest. To enter, a parent or legal guardian must complete the survey form provided on behalf of their child.
- **6) Alternative Entry**: A parent or legal guardian of a student may enter into this Giveaway during the entire Entry Period by emailing social@khanacademy.org with the subject line: "Enter me in the National Civics Bee Giveaway" and include a message confirming that

you agree to the Official Terms, and want to submit an Alternative Entry on behalf of your child ("Alternative Entry").

- 7) Your Compliance with School and District Policies: Teachers are responsible for determining (and confirming) that their participation in this Giveaway is permitted by your school and any applicable policies, including any school district and school policies.
- 8) Your Compliance with these Official Terms: Limit 1 Entry per person during the Entry Period. All Entries must be submitted during the Entry Period to be eligible. Proof of submission of Entry does not constitute proof of receipt of same. All Entries are subject to confirmation and/or verification and compliance with these Official Rules as determined by Sponsor. Sponsor reserves the right, in its sole and absolute discretion, to disqualify any Entries that do not comply with these Official Rules. Easypromos is a self-service online platform that guarantees the transparency and result of the sweepstakes and provides a certificate of validity for each one of the sweepstakes. The result of the winner selection using the random winner picker tool cannot be altered by the organizer and can be shared with any participant who requests it from the promoter. Decisions of the Sponsor as to the selection of the winner will be final.
- **10) Winner Notification and Prize Claiming**: The potential winner will be notified by email on or about Tuesday, February 6, 2025 with a request to supply a mailing address within 3 days of the date of notification ("**Confirmation Period**").
